Thank you for your interest regarding a Trade Site at our annual show. A deposit of \$15 must be received with your application by 1 August 2019. Refunds will only be made if the Secretary receives notification of cancellation by 11 August 2019.

Upon payment you will be issued with one (1) only entry pass to enable one (1) adult and a vehicle to enter the grounds. Additional entry passes are available for a fee.

Set up time is 6am on Saturday. Vehicles MUST be parked off site by 8am. Dogs are allowed but must be restrained at all times. Trading Times: 8am – 5pm.

**Site Fee:** \$35.00 per site (3 x 3m sq). \$5 extra per metre for ever metre over 3m frontage.

**Camping Fee:** \$5.00 per site, per night.

**Additional Passes:** Adult \$12.00 Child (up to 17 yrs) \$6.00

**Powered Site:** \$5.00 per site.

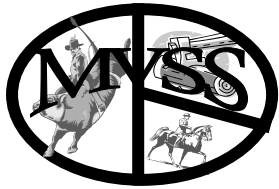

## INDEMNITY FORM TRADE SITE

### HOLD HARMLESS / INDEMNITY AGREEMENT WITH SERVICE PROVIDERS

I/We .....referred to hereafter as the Stall holder/Contractor, hereby expressly covenants and agrees with the Mary Valley show Society Inc to indemnify and keep indemnified its officer, employees, volunteers members and agents from and against all actions, claims, demand, costs and expenses (including costs of defending and settling the action, claim or demand) made, sustained, brought or prosecuted in any manner based upon, occasioned by, or attributable to any injury (including death) or any loss or damage to property or financial loss to or suffered by any person (and whether that person is a servant, agent, independent contractors, stallholders, volunteers, licensee or invitee of the Association or otherwise, which may arise from or in connection with the services, works or any other activities provided the Contractor, their servants, agents, officer, employees and associates (other than arising out of, or in connection with the negligent acts, omissions or errors of the Mary Valley Show Society).

### WORKPLACE HEALTH AND SAFETY ACT

Any exhibitors intending to bring electrical equipment to the Showgrounds will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of all exhibitors and the general public and is a requirement of the Workplace health and Safety Act of 1998. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at Mary Valley Showgrounds. Exhibitors should check all electrical equipment and leads before coming to the Showgrounds to avoid the occurrence of any difficulties.

A Committee requirement is for each site holder to have their OWN PUBLIC LIABILITY INSURANCE COVER OF \$10,000,000.00 and by signing this form is an acceptance that a current liability cover is in place.

PLEASE SUPPLY A COPY OF THE PUBLIC LIABILITY INSURANCE POLICY, AND IF APPLICABLE A WORKPLACE HEALTH AND SAFETY CERTIFICATE WITH THIS DOCUMENT.

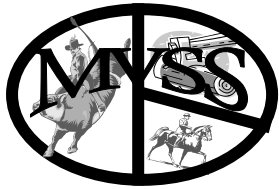

## **PROHIBITED ITEMS FOR TRADE SITE** *SATURDAY 17 AUGUST 2019*

The Queensland chamber of Agricultural Societies Inc has agreed that the following lines be banned at country Agricultural shows.

**Please note the items below are not acceptable for sale by stallholders:**

- Explicit and hardcore T-shirts
- Fake Cigarettes
- Fuel type fire lighters (Zippo)
- Knives (including pen knives)
- Metal and Wooden Martial Art weapons – eg. Numchucks
- Playing cards (nude or lurid)
- Pressure pack snow
- Drug related goods (including cocaine kits, bongs, etc)
- Stink bombs
- Water bombs
- Silly string
- Fireworks – crackers
- Water pistols; over 150mm (6")
- Laser pointers

Toy guns are acceptable, however the following are not:

- Pellet guns – ball bearing guns
- Replica guns (bullet type) – Pop downs (throw downs)
- Eight shot caps – Strip caps – Roll caps

**Additionally, no stalls will sell Food or Drink unless organised directly with the Mary Valley Show Society prior to the event.**
